AGGREEMENT BOND FOR CANDIDATES SEEKIN ADMISSION TO POST – GRADUATE COURSES

This indenture bond made at _____ the days of

Two thousand _____ between the Government of Gujarat (here in after referred to as the Govt.) which expression shall unless the context otherwise admits include his successor in office and assigns of the one part and

Shri / Kum. _____

Inhabitant of _____ in the Taluka of _____ district (here in after referred to as the candidate) of which expression shall unless the context otherwise admits, include his / her/ heirs, administrators, Executors and assigns of the other part.

WHERE AS the Government has decided to prescribe a condition for admission to Government Medical Colleges for the postgraduate degree and diploma courses hereafter referred to said course the every candidate so selected shall complete the said course from the college and that on such completion he/she shall if so required by the Government, serve in any of the rural areas of the state for a minimum period of three years on such remuneration as may be prescribed there of and shall furnish a suitable bond for the due performance of the said condition.

AND WHEREAS the students who had applied for admission for the said course in Shri M. P. Shah Government Medical College Jamnagar (here in after referred to as the said College) has been admitted for the said course.

Now the condition of the above written obligations is that if the student shall.

- 1) Fail to complete the three year P. G. Course as here in above provided the candidate shall pay to the Government on demand the amount of penalty of the bond as prescribed here under.
- 2) Diligently prosecute and complete the said course at the said college or any other medical college in the state and pass the prescribed university examination for the said course and within a period of 30 days from the date of his/her completing the period of post graduate course give to the Government by REGISTERED POST NOTICE in writing intimating the completion his/her post graduate studies.

And

- 3) When called upon by the Government at any time within a period six months from the receipt of the notice from the student as aforesaid join the state services and serve in rural areas any where in the state for a minimum period of THREE YEAR (in rural are any where in the state including one year service in any of the treble areas of the state), at such remuneration as may be prescribed there fore and in the event of the student not being so called for upon by the Govt. to join the state services and serve them for three years or serve the state Govt. in the rural areas for the aggregate period of 3 years and during the period during which the Government is required to serve under the provision of this Bond faith discharge the duties assigned to his / her by the Govt. or his/ her other superiors with the utmost diligence and efficiency and shall observe the rules for time being in force regulating the conduct of persons so serving.

Then the above written bond shall become void otherwise the said shall remind full force and virtue.

And in the event of student committing a breach of any of the above terms and conditions the whole of the amount Rs. 10,00,000 (Rupees Ten Lacs only) shall become payable, jointly or separately by the student or surety of the student and the above

And upon making of such payment the above written obligation shall be void and of no effect, otherwise it shall be and remain in full force and virtue.

Provided always and it is here by agreed and declared that the decision of the Government as to whether the said students has or has not performed and observed any of the obligations and conditions here in before recited shall be final and binding on the part here to.

Provided further that the liability of the surety here under shall not be impaired or discharged by the reasons of time being granted or any for bearance, act of admission of the Govt. (With or without the knowledge or consent of the surety.) in respect of or in relation the several obligations and conditions to be performed or discharged by the student.

Provided that the Govt. may without prejudice to any other rights or remedies of the Govt. to recover such amounts due here under from the student or from the surety as an arrearies of land revenue and provided further that this bond shall in all respect be Governed by laws of India. The expences of stamp duty on the bond if any, shall be born by the Government.
