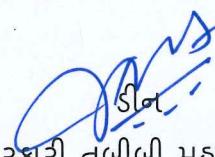

 - F) All prescribed qualifications will be counted as on date of Walk-in-interview
 - G) The appointment will be purely on contractual basis and under no circumstances are linked to regular appointments and cannot be regularized at any stage.
 - H) The emoluments will be consolidated in nature **40000=00 (Forty Thousands) per month.**

- I) The appointment can be terminated by the competent authority any time before one year also, without assigning any reason thereof.
- J) The Dean, Government Medical College, Surat reserve the rights to cancel the advertisement at any point of time without prior notice or fill up less number of posts as advertised depending upon the institutional requirements.

Document Verification: After scrutiny/ verification of the documents as per eligibility criteria, only eligible candidates shall be able to appear before the selection committee for interview. No Objection Certificate from the current employer and produce all relevant original documents in proof of details furnished in their application at the time of interview.

TERMS & CONDITIONS

- 1) The candidate who is already in government service shall submit "No Objection Certificate" from the present employer at the time of Interview.
- 2) Canvassing of any kind will lead to disqualification.
- 3) The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
- 4) He / She is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
- 5) The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available/applicable to the Government Servants, appointed on regular basis.
- 6) The appointment can also be terminated at any time, on either side, by giving one month's notice or by paying one month's salary, without assigning any reason or failure to complete the period of three months to the satisfaction of competent authority. The appointee shall be on the whole-time appointment of the Government Medical College, Surat and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
- 7) Leave entitlement of the appointee shall be governed as per the existing rules of the Institute for Contractual Employees.
- 8) The appointee shall not be entitled to avail of any allowances/facilities being extended to the regular/permanent faculty members of the Government Medical College, Surat.
- 9) The candidate should not have been convicted by any Court of Law.

- 10) In case any Information produced by candidate is found to be false than he/she is liable to be removed and any action taken as deemed to be fit by the appointing authority may be taken.
- 11) The decision of competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
- 12) Application incomplete in any regard will be rejected.
